DESCRIPTION OF THIS FUND


The Conservative Balanced Fund invests mainly in income assets (cash and cash equivalents and fixed interest), with some exposure to growth assets (equities, listed property and listed infrastructure). The fund may also invest in alternative assets.

The Conservative Balanced Fund aims to achieve (after the fund charge and before tax) over the long term low to moderate returns, allowing for small to moderate ups and downs in value.

WHAT ARE THE RISKS OF INVESTING?



EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$607 (that is 6.07% of her initial \$10,000). Sarah did not pay any other charges. This gives Sarah a total return after tax of \$607 for the year.




Actual investment mix²
