Losing traction

Summary

- In September, the Light Traffic Index fell 0.3% m/m while the Heavy Traffic rose 2.4% m/m, in only a partial bounce-back from last month's fall.
- Annual growth in the Light Traffic Index held steady in the month but remains in a trend decline, suggesting economic growth is going to continue to wane for a while yet.
- The Heavy Traffic Index has had its weakest quarterly growth in 7 years, suggesting GDP growth will be weak in Q3.

Annual growth in the three-month average of both the Light Traffic Index and the Heavy Traffic Index is currently sitting around zero. The Light Traffic Index gives a six-month lead on GDP growth while the Heavy Traffic Index is real-time, but they both agree that the economy is going to continue to lose momentum into the end of the year.

On a quarterly basis, the Light Traffic Index suggests that quarterly growth will continue to trend down over at least the next six months (figure 2). However, it is important to note that the growth in traffic is still consistent with positive GDP growth outturns, albeit modest ones. It looks nothing like 2008/09, when light traffic growth bottomed out at -2% q/q.


For its part, the quarterly change in the Heavy Traffic Index is sending a very weak signal for Q3 GDP growth (figure 3). In addition, there is the most convincing evidence of heavy traffic breaking under its trend since at least 2012 and arguably since 2008 (figure 4). It is volatile though, so this could yet abruptly turn around.


After adjusting for seasonality, traffic flows lifted on all of the 11 roads in the Heavy Traffic Index in September, and on 4 of the 10 roads in the Light Traffic Index.


