Edging up

Summary

- In November, the Light Traffic Index rose 1.2% m/m, busting out of its recent plateau. The Heavy Traffic fell 1.5% m/m, but this follows two strong monthly increases.
- Annual growth in both indexes is lifting off low levels. It suggests annual GDP growth is going to continue to be unimpressive for a while yet. But things are looking better in a momentum sense.


The two ANZ Truckometer indexes reflect economic activity. The Light Traffic Index gives an indication of where GDP growth will be in six months' time, while the Heavy Traffic Index is real-time. They both agree that the economy is has lost considerable momentum, but the data has improved in the past few months, consistent with the lift in 'soft' data such as our ANZ Business Outlook survey and the PMI.

Given the volatility in the indexes it is certainly too soon to say that they have definitively turned the corner. But that said, the recent lift in annual growth in the two indexes is supportive of our view that annual GDP growth is set to bottom out around the current level of 2%.

To extract a signal for quarterly growth one has to smooth the traffic data quite a bit, which means turning points can take a while to show up. Current growth in the 6-month average of the Light Traffic Index is hardly inspiring, but it is at least suggesting positive GDP growth outturns, albeit modest ones, over the next six months (figure 3).




Figure 4. ANZ Light Traffic Index (adv. 6 months) and GDP

And those looking for a cheerier picture can note that the level of light traffic has busted out of the flattish plateau it has been in for some time (figure 4), though spikes in both directions aren't uncommon.

Tables and charts

After adjusting for seasonality, traffic flows lifted on 3 of the 11 roads in the Heavy Traffic Index in November, and on 7 of the 10 roads in the Light Traffic Index.





Figure 7. ANZ Heavy Traffic Index: raw vs. seas. adj.


