December dip

Summary

- In December, the Light Traffic Index fell 2.0% m/m, while the Heavy Traffic fell 2.5% m/m, on top of a fall in November.
- Annual growth in light traffic is still lifting but that of heavy traffic has now plateaued. The Light Traffic Index is the better economic indicator of the two; it suggests annual GDP growth will bounce around the 2% mark into the middle of next year.


The two ANZ Truckometer indexes reflect economic activity. The Light Traffic Index gives an indication of where GDP growth is headed in six months' time, while the Heavy Traffic Index is real-time. They agree that the slowdown in economic momentum may be finding a floor, consistent with our economic forecasts.

But that said, the recent lift in annual growth in the two indexes is supportive of our view that annual GDP growth is set to bottom out around the current level of 2%.

We have undergone the annual process of recalculating historical weights in the indexes following historical GDP revisions. We also took the opportunity to swap out 1-2 roads in each index for more useful ones. The resulting revisions are minor.

The Light Traffic Index is suggesting modest positive GDP growth outturns over the next six months (figure 3).

We now have complete data for the December quarter. A model using the Heavy Traffic Index both contemporaneous and lagged one quarter, and the Light Traffic Index lagged two quarters, suggests growth of 0.5% q/q.




Figure 4. Quarterly GDP: historical and modelled using ANZ Truckometer indexes





Figure 7. ANZ Heavy Traffic Index: raw vs. seas. adj.

Figure 6. ANZ Light Traffic Index and GDP





Figure 8. ANZ Light Traffic Index: raw vs. seas. adj.
