Description of this fund


The Cash Fund invests mainly in cash and cash equivalents. These may include investments issued by New Zealand-registered banks, the New Zealand Government, corporations or local authorities, or non-New Zealand governments.

The Cash Fund aims to achieve (after the fund charge and before tax) over the long-term a yearly return broadly in line with the relevant market index

What are the risks of investing?

Risk indicator for the Cash Fund:



Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$101 (that is 1.01% of her inital \$10,000). Sarah did not pay any other charges. This gives Sarah a total return after tax of \$101 for the year.




Actual investment mix³
