What is the purpose of this update?

This document tells you how the High Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. ANZ New Zealand Investments Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The High Growth Fund invests in growth assets (equities, listed property and listed infrastructure), with a very small exposure to income assets (cash and cash equivalents and fixed interest). The fund may also invest in alternative assets.

The High Growth Fund aims to achieve (after the fund charge and before tax) over the long term higher returns, allowing for larger ups and downs in value.

What are the risks of investing?

Risk indicator for the High Growth Fund¹:

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. While risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future fund updates.


How has the fund performed?

The market index annual return is calculated using the target investment mix and the indices of each asset class. The composition of the market index for this fund changed effective 23 October 2025 due to a change in the target investment mix and the underlying market indices for the cash and cash equivalents, New Zealand fixed interest and international fixed interest asset classes. These changes were made to more accurately reflect the fund's investment strategy.

* The manager expects the fund charges for the next scheme year will be less than the fund charges disclosed in this fund update because the manager's basic fee was reduced to 0.91% effective 1 August 2024.

Small differences in fees and charges can have a big impact on your investment over the long term.


Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$1,061 (that is 10.61% of her initial \$10,000). Sarah did not pay any other charges. This gives Sarah a total return after tax of \$1,061 for the year.

Actual investment mix³


This shows the types of assets that the fund invests in.
