### WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the High Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. ANZ New Zealand Investments Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### DESCRIPTION OF THIS FUND

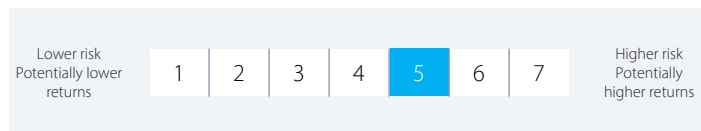
The High Growth Fund invests in growth assets (equities, listed property and listed infrastructure), with a very small exposure to income assets (cash and cash equivalents and fixed interest). The fund may also invest in alternative assets.

The High Growth Fund aims to achieve (after the fund charge and before tax) over the long term higher returns, allowing for larger ups and downs in value.

### WHAT ARE THE RISKS OF INVESTING?

Risk indicator for the High Growth Fund<sup>1</sup>:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

The High Growth Fund opened for investment on 3 August 2023, so a mix of market index returns and the fund's actual returns have been used to calculate the risk indicator for the five-year period to 31 March 2025. Market index returns have been used for the period 1 April 2020 to 31 July 2023. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. While risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future fund updates.

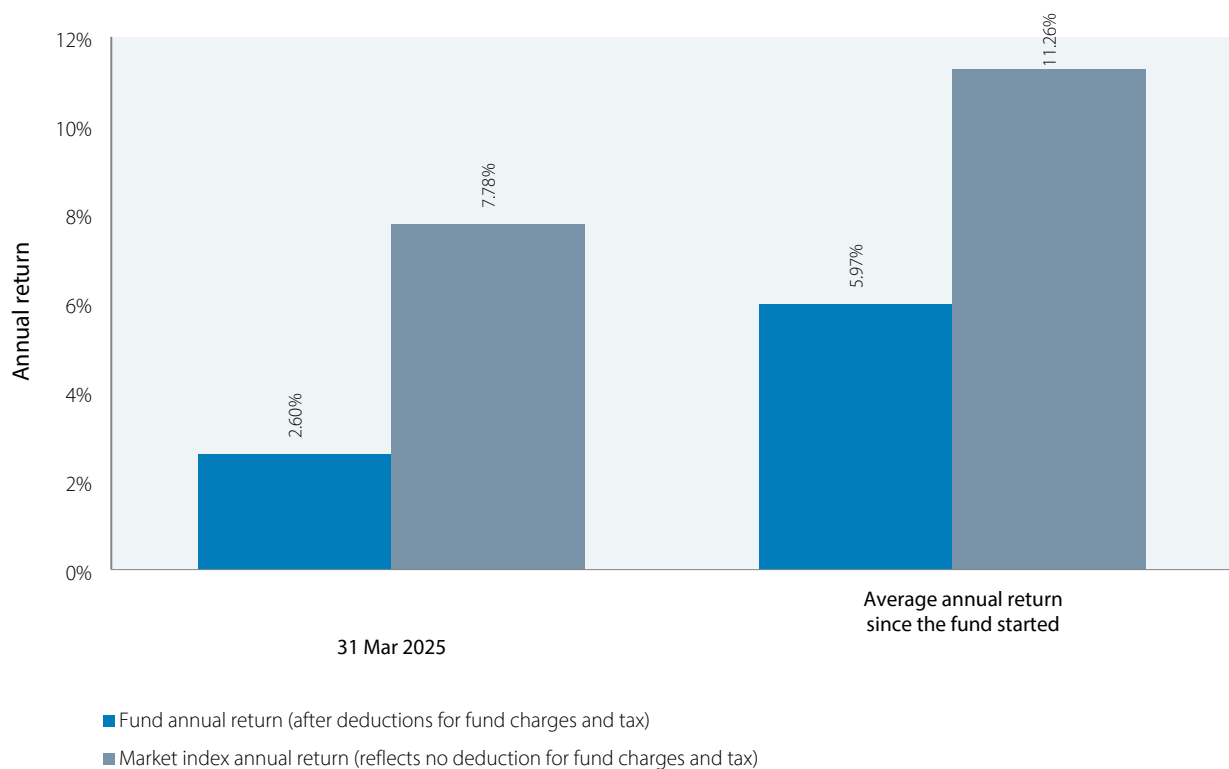
## HOW HAS THE FUND PERFORMED?

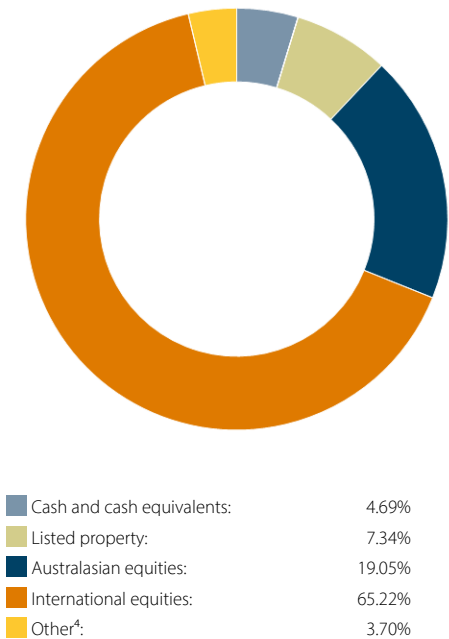
EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$260 (that is 2.60% of her initial \$10,000). Sarah did not pay any other charges. This gives Sarah a total return after tax of \$260 for the year.

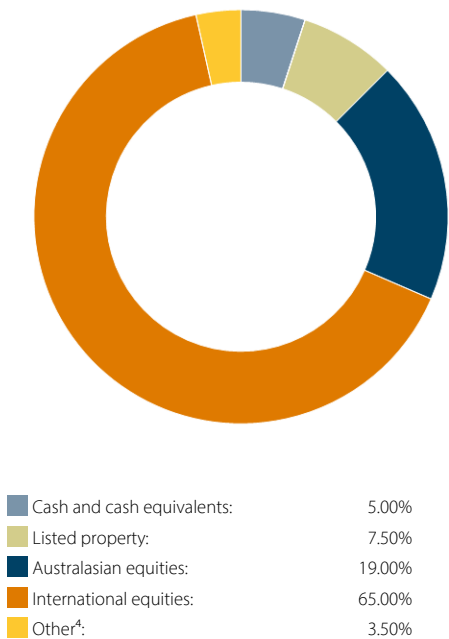
Actual investment mix<sup>3</sup>
