WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the High Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. DESCRIPTION OF THIS FUND

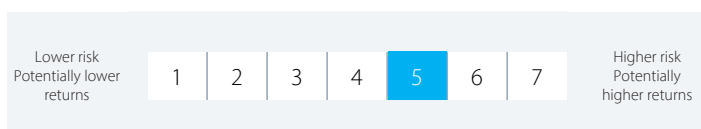
The High Growth Fund invests in growth assets (equities, listed property and listed infrastructure), with a very small exposure to income assets (cash and cash equivalents and fixed interest). The fund may also invest in alternative assets.

The High Growth Fund aims to achieve (after the fund charge and before tax) over the long term higher returns, allowing for larger ups and downs in value.

WHAT ARE THE RISKS OF INVESTING?

Risk indicator for the High Growth Fund¹:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Market index returns have been used for the period 1 July 2019 to 31 July 2023. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. While risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future fund updates.

*The manager expects the fund charges for the next scheme year will be less than the fund charges disclosed in this fund update because the manager's basic fee is to be reduced effective 1 August 2024 from 0.95% to 0.91% per year.

Small differences in fees and charges can have a big impact on your investment over the long term.

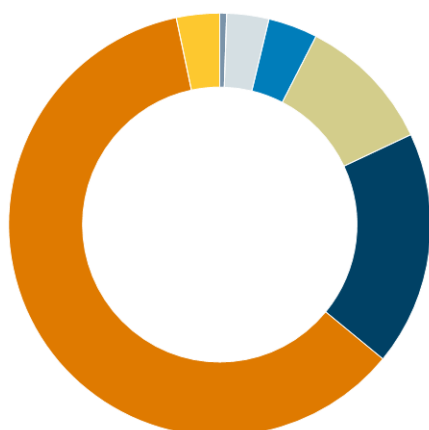
EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Sarah had \$10,000 in the fund at 4 August 2023 (the date the fund started) and did not make any further contributions. At 30 June 2024, Sarah received a return after fund charges were deducted of \$560 (that is 5.60% of her initial \$10,000). Sarah did not pay any other charges. This gives Sarah a total return after tax of \$560 for the period.
