
The High Growth Fund aims to achieve (after the fund charge and before tax) over the long term higher returns, allowing for larger ups and downs in value.


EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR


Sarah had \$10,000 in the fund at 3 August 2023 (the date the fund started) and did not make any further contributions. At 30 September 2023, Sarah incurred a loss after fund charges were deducted of \$491 (that is -4.91% of her initial \$10,000). Sarah did not pay any other charges. This shows the types of assets that the fund invests in.






Target investment mix³
