#### What is the purpose of this update?

This document tells you how the Australasian Property Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. ANZ New Zealand Investments Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### Description of this fund

The Australasian Property Fund invests mainly in New Zealand and Australian listed property assets. Investments may include: • listed companies, funds or trusts that invest in property, and


• cash and cash equivalents.

The fund aims to achieve a positive yearly return (after the fund charge and before tax) that over the long-term outperforms the relevant market index.

#### What are the risks of investing?

Risk indicator for the Australasian Property Fund:

Note that even the lowest category does not mean a risk-free investment, and there may be other risks that are not captured by this rating.



Small differences in fees and charges can have a big impact on your investment over the long term.

## Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$1,976 (that is 19.76% of her initial \$10,000). Sarah also paid \$24 in other charges. This gives Sarah a total gain after tax of \$1,952 for the year.




#### Actual investment mix<sup>3</sup>
