What is the purpose of this update?

Description of this fund

The Australasian Property Fund invests mainly in New Zealand and Australian listed property assets. Investments may include:


- companies, funds or trusts that invest in property and are listed or intend to list, and
- cash and cash equivalents.

The fund aims to achieve a positive yearly return (after the fund charge and before tax) that over the long-term outperforms the relevant market index

What are the risks of investing?

Risk indicator for the Australasian Property Fund:



From 1 April 2019, the membership fee was removed for members under 18 years and reduced from \$24 to \$18 per year for all other members.

Investors are not currently charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). See the PDS for more information about Scheme fees.

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$2,724 (that is 27.24% of her initial \$10,000). Sarah also paid \$24 in other charges. This gives Sarah a total gain after tax of \$2,700 for the year.




Actual investment mix³
