# OneAnswer KiwiSaver Scheme

#### What is the purpose of this update?

This document tells you how the Australasian Share Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. ANZ New Zealand Investments Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

The Australasian Share Fund invests mainly in New Zealand and Australian equities. Investments may include: • equities in companies that are listed or intend to list on the New Zealand or Australian stock exchanges, and


cash and cash equivalents.

The fund aims to achieve a positive yearly return (after the fund charge and before tax) that over the long-term outperforms the relevant market index.

### What are the risks of investing?

Risk indicator for the Australasian Share Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



Small differences in fees and charges can have a big impact on your investment over the long term.

## Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$1,032 (that is 10.32% of her initial \$10,000). Sarah also paid \$18 in other charges. This gives Sarah a total gain after tax of \$1,014 for the year.




## Actual investment mix<sup>3</sup>

#### Notes

1. Our fund charges are inclusive of GST, where applicable.

2. From 1 May 2020, the membership fee was removed for members over 65 years. If you are aged between 18 and 65 years, we will charge you a membership fee at the scheme level for looking after your KiwiSaver account. If you're invested in more than one fund, this fee will be deducted from the fund with the highest balance.

3. The target and actual investment mix of this fund are based on:

- the cash and cash equivalents held by the fund, and

- the asset class of the underlying fund in which the fund invests.

They are not based on the cash and cash equivalents or any other assets held by the underlying fund.
