What is the purpose of this update?

Description of the fund


The Cash Fund invests mainly in cash and cash equivalents. These may include investments issued by New Zealand-registered banks, the New Zealand Government, corporations or local authorities, or non-New Zealand governments.

The Cash Fund aims to achieve a positive yearly return (after the fund charge and before tax) that over the long-term is broadly in line with the relevant market index.

What are the risks of investing?

Risk indicator for the Cash Fund:

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$37 (that is 0.37% of her initial \$10,000). Sarah also paid \$18 in other charges. This gives Sarah a total gain after tax of \$19 for the year.




Actual investment mix³
