# Sustainable International Share Fund

### What is the purpose of this update?

This document tells you how the Sustainable International Share Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. ANZ New Zealand Investments Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

The Sustainable International Share Fund invests mainly in international equities with a focus on environmental, social and governance (ESG) considerations. Investments may include:

- equities in companies that are listed on a recognised stock exchange and
- cash and cash equivalents.

The fund aims to achieve a positive yearly return (after the fund charge and before tax) that over the long-term outperforms the relevant market index.

### What are the risks of investing?

Risk indicator for the Sustainable International Share Fund:



<sup>\*</sup>The manager expects that the fund charges for the next scheme year will be less than the fund charges disclosed in this fund update because effective 28 June 2021 the manager's basic fee was reduced from 1.15% to 0.85% per year and the maximum 'other management and administration charges' that may be charged reduced to 0.11% per year.

Investors are not currently charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). See the PDS for more information about Scheme fees.

Small differences in fees and charges can have a big impact on your investment over the long term.

### Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$2,208 (that is 22.08% of her initial \$10,000). Sarah also paid \$18 in other charges. This gives Sarah a total gain after tax of \$2,190 for the year.
