DESCRIPTION OF THIS FUND


The Australasian Property Fund invests mainly in New Zealand and Australian listed property assets. Investments may include companies, funds or trusts that invest in property and are listed or intend to list, and cash and cash equivalents.

The Australasian Property Fund aims to achieve a positive yearly return (after the fund charge and before tax) that over the long-term outperforms the relevant market index.

WHAT ARE THE RISKS OF INVESTING?



^{*}The manager expects that the fund charges for the next scheme year will be less than the fund charges disclosed in this fund update because the manager's basic fee was reduced effective 3 August 2023 from 1.00% to 0.95% per year.

EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah incurred a loss after fund charges were deducted of \$591 (that is -5.91% of her initial \$10,000). Sarah did not pay any other charges. This gives Sarah a total loss after tax of \$591 for the year.




Actual investment mix²
