WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the Cash Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. ANZ New Zealand Investments Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

DESCRIPTION OF THIS FUND

The Cash Fund invests in cash and cash equivalents. These may include investments issued by New Zealand-registered banks, the New Zealand Government, corporations or local authorities, or non-New Zealand governments.

The Cash Fund aims to achieve (after the fund charge and before tax) over the short term lower but stable returns, allowing for smaller ups and downs in value.

WHAT ARE THE RISKS OF INVESTING?

Risk indicator for the Cash Fund:




EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$353 (that is 3.53% of her initial \$10,000). Sarah did not pay any other charges. This gives Sarah a total return after tax of \$353 for the year.


Actual investment mix²
