WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the Sustainable International Share Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. ANZ New Zealand Investments Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

DESCRIPTION OF THIS FUND

The Sustainable International Share Fund invests mainly in international equities with a focus on environmental, social and governance (ESG) considerations. Investments may include equities in companies that are listed on a recognised stock exchange, and cash and cash equivalents.

The Sustainable International Share Fund aims to achieve a positive yearly return (after the fund charge and before tax) that over the long-term outperforms the relevant market index.

WHAT ARE THE RISKS OF INVESTING?

Risk indicator for the Sustainable International Share Fund:




EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$1,330 (that is 13.30% of her initial \$10,000). Sarah did not pay any other charges. This gives Sarah a total return after tax of \$1,330 for the year.


Actual investment mix²
