# **Conservative Fund**

#### What is the purpose of this update?

This document tells you how the Conservative Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. ANZ New Zealand Investments Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### Description of this fund

The Conservative Fund invests mainly in income assets (cash and cash equivalents and fixed interest), with a smaller exposure to growth assets (equities, listed property and listed infrastructure). The fund may also invest in alternative assets.

The Conservative Fund aims to achieve (after the fund charge and before tax) over the long-term a modest yearly return allowing for modest movements of value up and down including occasional negative yearly returns.

## What are the risks of investing?



<sup>\*</sup>The Manager expects that the fund charges for the next scheme year will be different from the fund charges disclosed in this fund update because the Manager's basic fee was reduced effective 30 September 2021 from 0.78% to 0.56% per year.

Investors are not currently charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). See the PDS for more information about Scheme fees.

Small differences in fees and charges can have a big impact on your investment over the long term.

## Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah incurred a loss after fund charges were deducted of \$825 (that is -8.25% of her initial \$10,000). Sarah did not pay any other charges. This gives Sarah a total loss after tax of \$825 for the year.




### Actual investment mix<sup>2</sup>
