WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the New Zealand Fixed Interest Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. DESCRIPTION OF THIS FUND

The New Zealand Fixed Interest Fund invests mainly in New Zealand fixed interest assets. Investments may include fixed interest assets in New Zealand dollars, or issued by New Zealand located or incorporated entities and hedged back to New Zealand dollars, and cash and cash equivalents.

The fund aims to achieve a positive yearly return (after the fund charge and before tax) that over the long-term is broadly in line with the relevant market index.

WHAT ARE THE RISKS OF INVESTING?



This gives Sarah a total return after tax of \$777 for the year.




Actual investment mix²
