### WHAT IS THE PURPOSE OF THIS UPDATE?

#### **DESCRIPTION OF THIS FUND**


The Property Securities Fund invests mainly in New Zealand and Australian listed property assets. Investments may include companies, funds or trusts that invest in property and are listed or intend to list, and cash and cash equivalents.

The fund aims to achieve a positive yearly return (after the fund charge and before tax) that over the long-term outperforms the relevant market index.

#### WHAT ARE THE RISKS OF INVESTING?

Risk indicator for the Property Securities Fund:




# EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$283 (that is 2.83% of her initial \$10,000). Sarah did not pay any other charges. This gives Sarah a total return after tax of \$283 for the year.

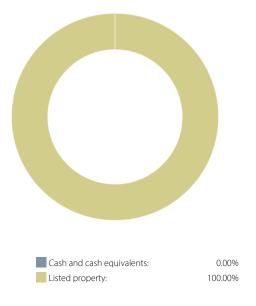
#### Actual investment mix<sup>2</sup>
