What is the purpose of this statement?

This statement provides key information about the ANZ KiwiSaver Scheme Cash Fund. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

Description of the fund

The Cash Fund invests in overnight deposits and term deposits with one or more New Zealand registered banks. The objective of the Cash Fund is to outperform the NZX NZ Bank Bill Index.

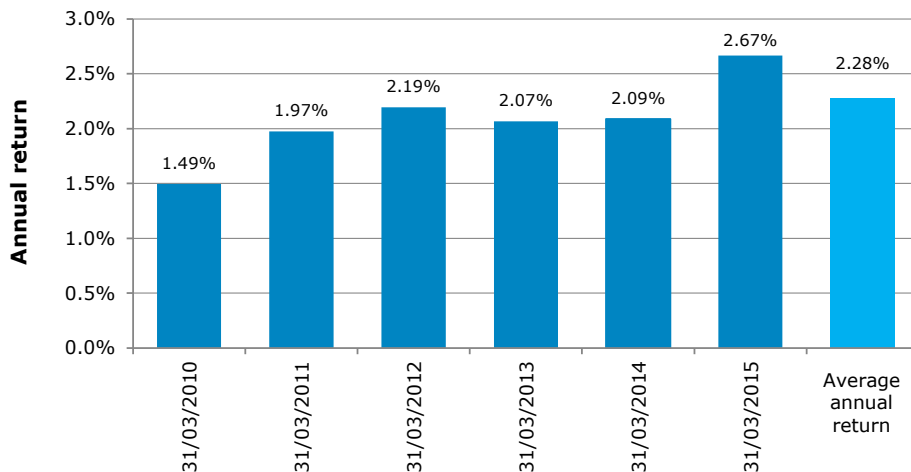

How has the fund performed in the past?

Members were also charged **membership fees**³ of up to \$24 over the year.

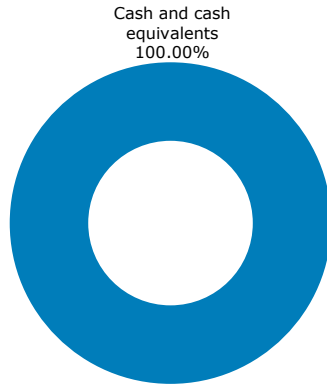
Example of how this applies to a member

Sarah had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Sarah received a return after fund fees and tax were deducted of \$267 (that's 2.67% of her initial \$10,000). Sarah also paid \$24 in membership fees³. This gives Sarah a total return of \$243 for the year.
