SUMMARY

- Prices in the Monthly Inflation Gauge rose 0.1% in May, following a 0.2% rise in April. Prices in the Gauge were up 0.7% 3m/3m, while annual inflation from the Gauge rose to 2.2%.¹
- Price rises were once again largely confined to the housing group, with prices unchanged in the Underlying Ex-housing Gauge, and the 3-month change in this measure flat as well.
- The annual inflation picture remains benign overall, but looks to be past its recent lows with rising pressures from some sectors such as housing. This tells us that demand-pull inflation is alive and well in some areas.

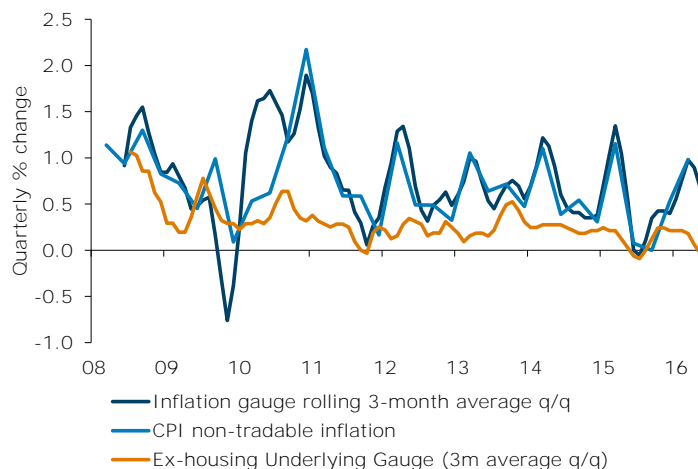
TWO-TONE

Prices from the Gauge registered a 0.1% lift in May, following a 0.2% rise in April. The general norm across the surveyed prices was for no change, with prices in hibernation heading into winter.

Despite this, May was the thirteenth consecutive month that showed increases for the housing group, due to rises for house prices, construction costs, dwelling maintenance services, and electricity charges. There were also other price increases throughout the Gauge, including professional services, physiotherapy charges, parking and gym fees. Tempering the rise were falls in the recreation & culture group and in transport group prices. Lower accommodation tariffs look to be mostly seasonal as well as the result of modest recoil from sizeable rises from late last year. Charges for cinema admissions also fell. Competitive pressures look to be the catalyst behind falls for airfares on most domestic routes.

Readings from our headline gauge have closely tracked non-tradable CPI outturns. Three-month inflation, at 0.7% in May, is largely the result of higher government charges and rises in housing group prices. Stripping these out delivers a flat outturn over this period.

¹ Our **Monthly Inflation Gauge** provides a **directional signal of broad trends and movements in non-tradable CPI inflation** produced by Statistics NZ, but at a monthly frequency. Differences in methodology and coverage mean the Gauge will not exactly mirror the official series. We also produce an Underlying Ex-housing Gauge that adjusts for indirect taxes and tertiary education fees and removes housing group prices.

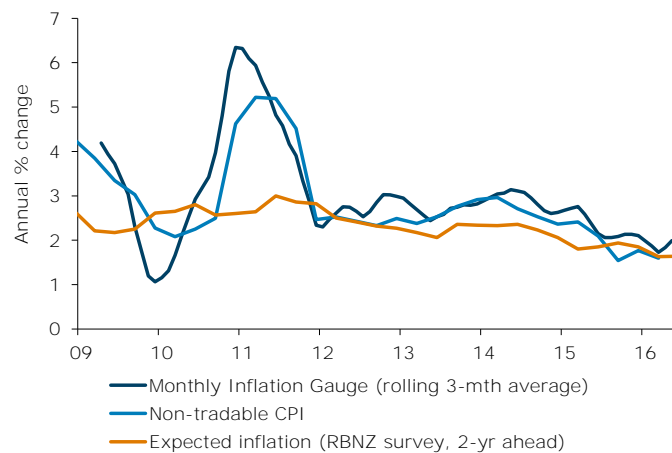
ANZ MONTHLY INFLATION GAUGE

We look to be past the lows for domestic inflation. Annual inflation in the Gauge ticked up to 2.2%, a 13-month high. Pockets of pricing pressure certainly exist, but they are largely limited to the government sector and housing. Annual inflation from the underlying ex-housing gauge remained moribund at 0.5% y/y.

We continue to see tension between the forces that are suppressing domestic inflation (technology, global trends, low wage inflation) and pockets where demand-pull inflation is alive and well. Meanwhile the NZD continues to soar, as do house prices. One infers lower rates are needed, while the other makes the case for higher borrowing costs.

The combination makes the outlook for the OCR delicately placed.
