



Win Airpoints Dollars with your ANZ Visa Business Airpoints card Terms and Conditions

The Win Airpoints Dollars with your ANZ Visa Business Airpoints card Promotion runs from 25 April to 31 July 2018 (the "Promotional Period"). Within the Promotion there is one prize draw with one major prize and 20 minor prizes.

A business will automatically receive one entry into the prize draw each time their ANZ Visa Business Airpoints card is used to complete an eligible purchase during the Promotional Period.

An eligible purchase means any single purchase successfully made on their ANZ Visa Business Airpoints card during the Promotional Period, other than cash withdrawals or payments for cash-equivalent transactions such as the purchase of traveller's cheques or gaming chips. Failed, reversed, refunded or declined transactions on eligible purchases will not provide entry into the prize draw.

The prizes are as follows:
