

ANZ BUSINESS OUTLOOK MORE SUBSTANCE THAN SPIN

The next issue of the ANZ *Business Outlook* is scheduled for release on 29 July 2016 at 1pm.

SUMMARY

- A firming in **business sentiment, firms’ own activity expectations and other components** of the survey flag accelerating economic momentum.
- Construction and services are the **pace-setters**, agriculture the laggard.

The votes are in; confidence across the grass-roots of the business sector increased in June. A net 20% of businesses are optimistic about prospects over the coming year, up 9 points on the month prior and reaching a six-month high. First past the post was the construction sector (at +37, the highest since March 2015), with bipartisan support from services (+36).

The zeitgeist is uniformly positive. A net 35% of firms are optimistic about prospects for their own business. **That’s** above average and strong. This is where the campaign can be either **won or lost; it’s not business sentiment itself** that matters but what businesses are doing and thinking about their own business. Their own back yard matters. **It’s strong.** No spin is required. Riding on the coattails of lifts in **firms’ own activity expectations** is the broader survey.

- Investment intentions rose two points to +17. Respectable. No need for affirmative action.
- Employment intentions were unchanged at +18.
- Profit expectations continue to rise; a net 22% of businesses expect a lift. **That’s a vote for jobs and investment.**
- Export intentions were a tad higher (+24 versus +21). Some checks and balances from a rising NZD but still up.
- Residential investment intentions were still high at +29 (previously +36). Commercial construction intentions waned a tad from +29 to +28.
- Inflation expectations lifted from 1.4% to 1.5%. Still a backbencher, though off lows. Pricing intentions continue to oscillate as opposed to trend. A net 20% expect to lift prices over the coming year, down a tad on the month prior.
- The picture, after adjusting for seasonality, is largely the same.

ANZ BUSINESS CONFIDENCE INDEX

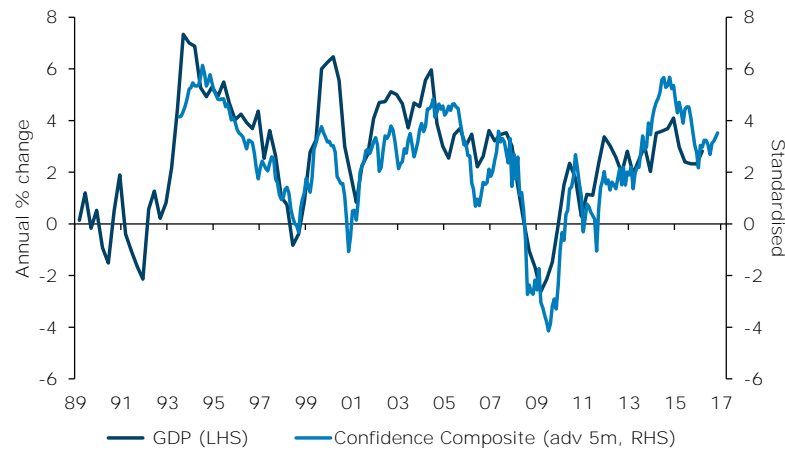

ANZ BUSINESS OUTLOOK

The past month has hardly seen a suite of good news, yet the good still outweighs the negatives. The RBNZ held rates steady (fewer respondents now expect the RBNZ to cut), the NZD has gone up, oil prices have risen and another low dairy payout year beckons. Political palpitations are aplenty around the globe. Yet there are heaps of Dorothy Dixers to crow about. Housing is booming. Little wonder construction is the front runner on almost every measure. GDP growth is solid. Migration is strong. Agriculture – outside of dairying – remains in good heart.

Our composite growth indicator (which combines business and consumer sentiment so we get both the producers' and the ultimate buyers' perspective) **is providing a strong mandate for growth. It's flagging growth in a 3-3½% range over the year ahead.**

More important is that it is flagging a potential acceleration in growth.

The survey has been adept at picking turning points before and we have no reason to doubt the validity of survey responses this time around.

The outlook for monetary policy (OCR) is challenging. The NZD is too high and housing (credit growth) too strong. Inflation is low but growth is strong, which signals rising inflation over time. The global scene has been knocked by Brexit. The latter means a lower OCR is probably still likely, despite the likes of business confidence saying the economy doesn't need it (at least for now).

FIGURE 1. ACTIVITY OUTLOOK INDEX

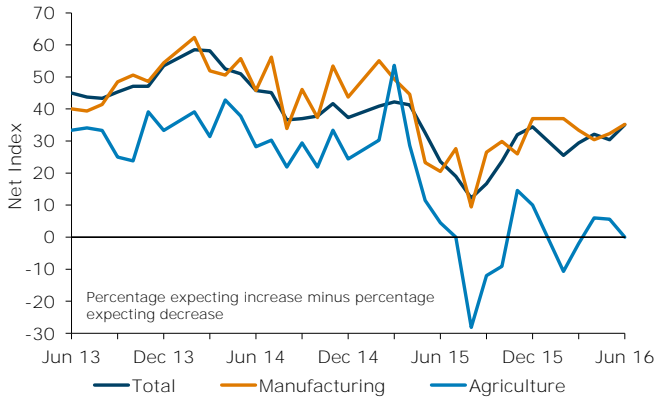


FIGURE 2. CONSTRUCTION INTENTIONS

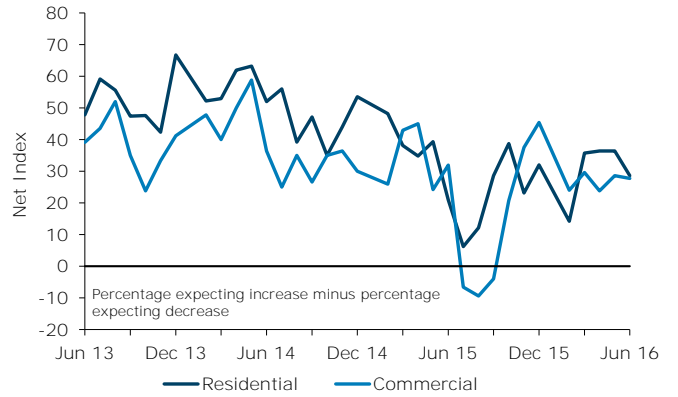


FIGURE 3. ACTIVITY OUTLOOK INDEX

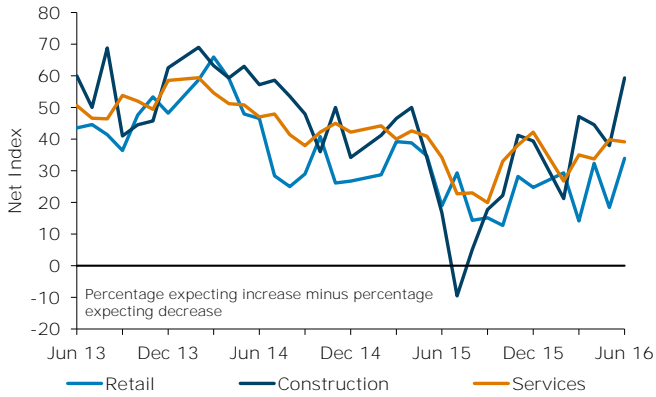


FIGURE 4. LABOUR MARKET OUTLOOK

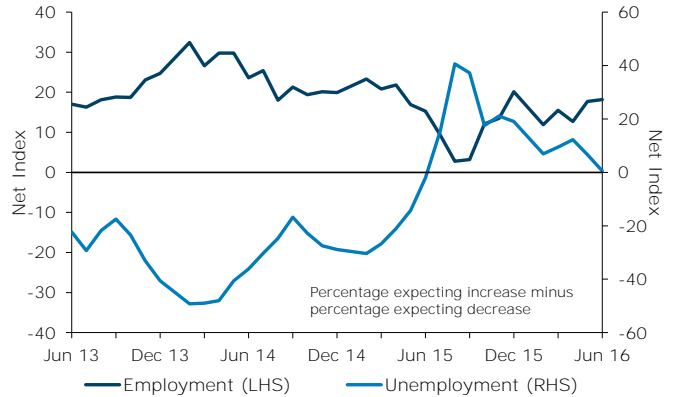


FIGURE 5. EXPORT SALES VOLUMES

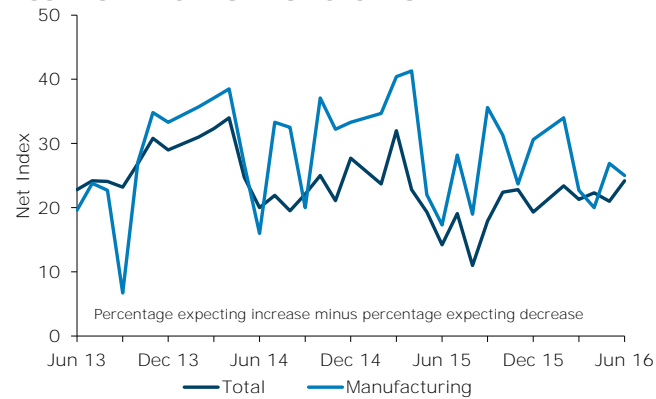


FIGURE 6. FINANCIAL OUTLOOK

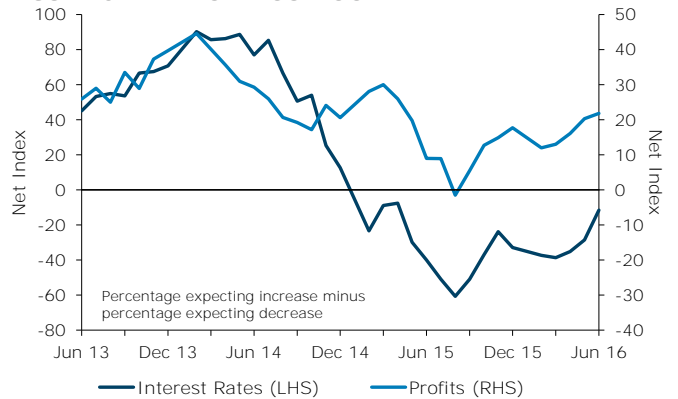


FIGURE 7. INVESTMENT INTENTIONS

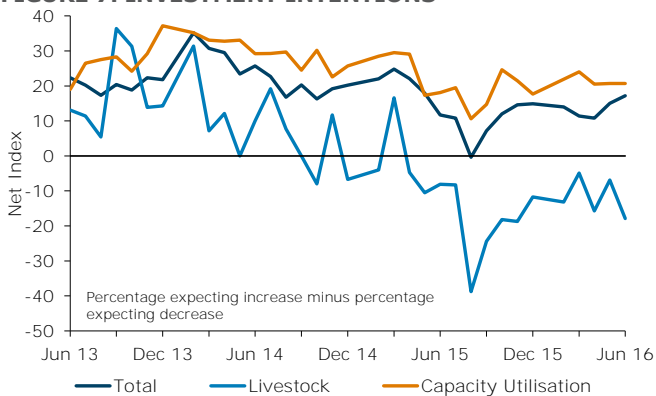
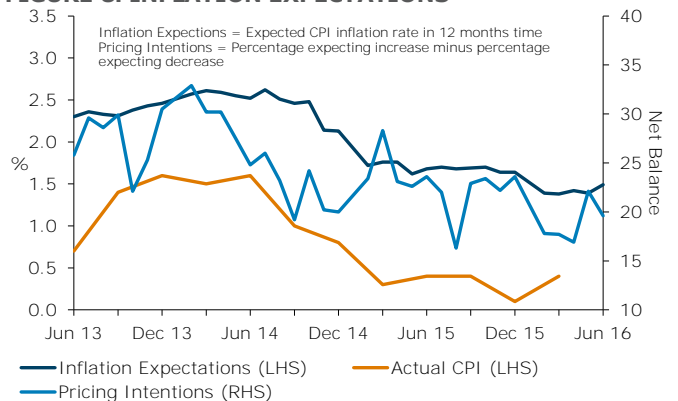


FIGURE 8. INFLATION EXPECTATIONS
