EASY DOES IT

SUMMARY

- ANZ job ads fell 1.0% m/m in July (seasonally adjusted) off a record high.
- Looking through the monthly noise, job ads growth has slowed to just 0.5% q/q. That moderation is reflected in annual job growth easing from a peak of 19.6% in January to 12.2% in July (3-month average). **That's a turning point.**
- Is labour demand coming off the boil or are workers simply becoming too difficult to find, with firms are giving up on advertising and looking at alternative means? With skilled staff the biggest problem holding back firms (according to our Small Business Monitor), **it's looking more like the latter.** There is not a pool of suitable labour for most firms despite the unemployment rate being 4.8%.
- **That's** a classic late-cycle challenge and signals pressure for wage growth to rise.
- Despite Auckland job ads falling for three months straight, it remains the strongest of the three main centres in annual growth terms (10.4%), but is now lagging the national average. Wellington and Canterbury job ads also fell in July. The less-urbanised regions are still experiencing stronger annual job ad growth than any of the three main centres.
- The construction, utilities, manufacturing and transport sectors continue to be the largest drivers of total job ads growth. The service sector is also contributing strongly, as is retail and tourism, and government.

ANZ NEW ZEALAND JOB ADS

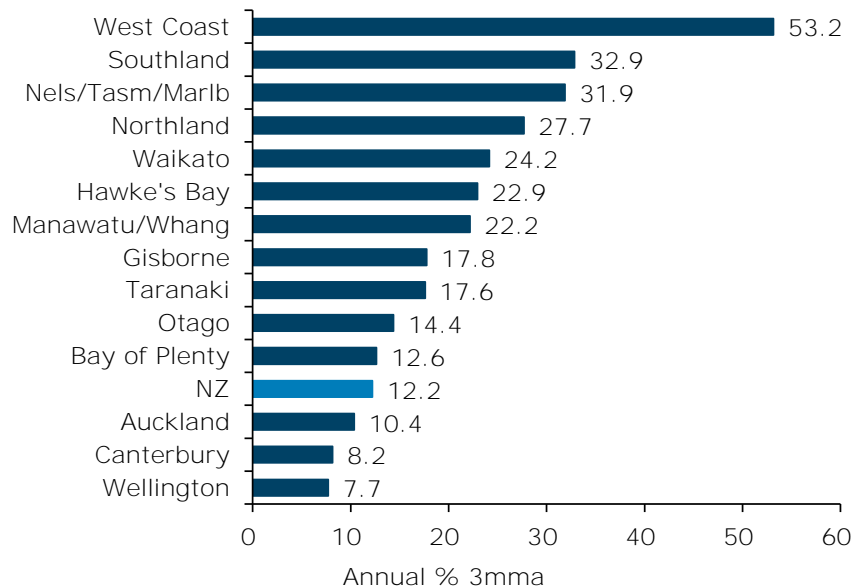
ANZ job ads fell 1.0% in July (seasonally adjusted). The level of job ads has flattened out, with declines in two of the past three months. That flags a turning point despite the fact job ads are still up 12.2% from a year ago, with levels near record highs.

Auckland remains the strongest of the main centres on an annual growth basis (+10.4% y/y) but the region is lagging the national growth rate, with the level of job ads in the Auckland region having fallen for three straight months.

Wellington job ads fell 1.5% m/m after a solid June lift (+7.7% y/y). **Canterbury job ads unwound their strong June jump (-3.8% m/m),** but annual growth eased only modestly to 8.2% (all reported annual growth rates are based on a 3-month average).

The regions continue to outperform. All of the 11 less-urbanised regions continue to experience stronger annual job ad growth than any of the three main centres (figure 2).

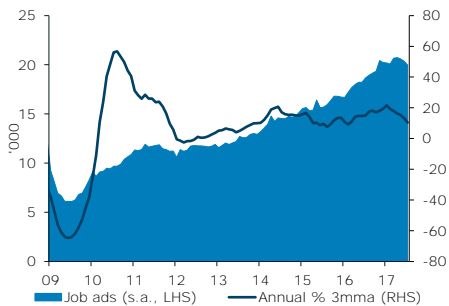


Figure 4. Wellington Job Ads

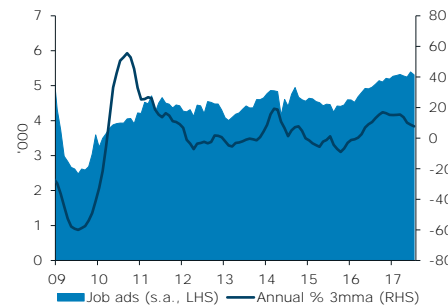
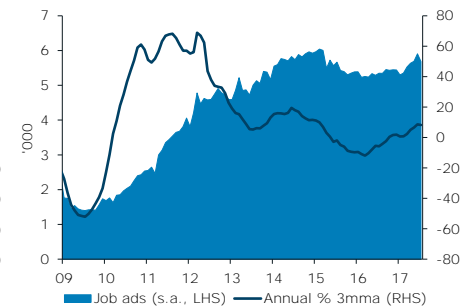


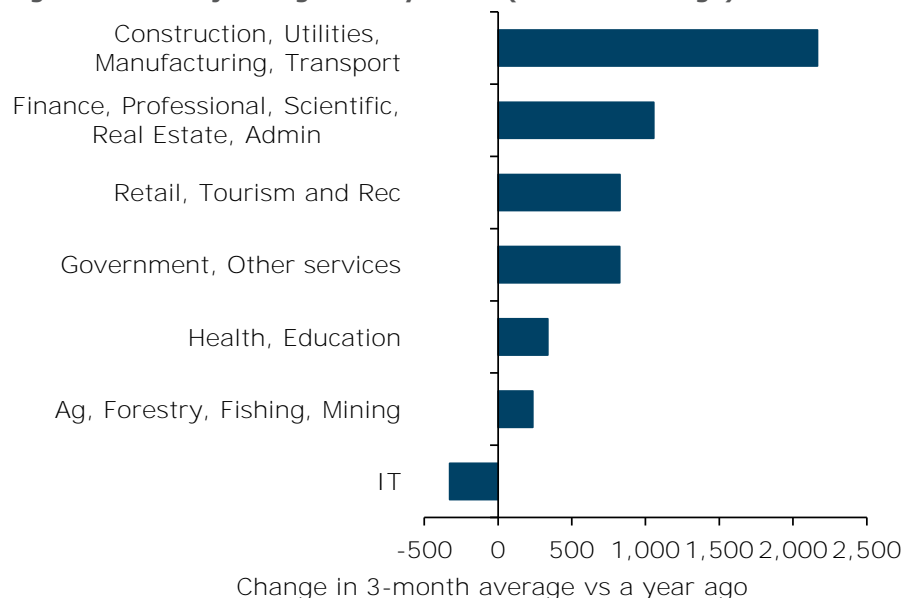
Figure 5. Canterbury Job Ads



ANZ NEW ZEALAND JOB ADS

The construction, utilities, manufacturing and transport sector continues to show the strongest annual growth in job ads (figure 6).¹

It is not surprising that job ads growth is easing after such a strong burst. However, it is notable that the *level* of job ads in Auckland now seems to have peaked, having dropped in each of the past three months. Some of this may reflect employers giving up on finding scarce skills, with a large proportion of firms reporting that finding staff is their biggest headache at present. However, it may also reflect a maturing of the economic cycle, and we will watch developments with interest.

While job ads growth has softened in recent months, **to put it in context, the unemployment rate fell in Q2 to the lowest level since 2008.** Such strong demand for labour and persistent skill shortages as we have seen would typically be associated with accelerating wage inflation.

We do indeed expect a modest increase in wage growth. However, we expect the increase to be capped by still-subdued CPI inflation and technological progress that is reducing job security and reducing traditional wage-bargaining power across a range of sectors.
